Note: Ex-Servicemen from IAF, having work experience on SU-30/MiG series of Aircraft, who have recently retired / discharged from IAF or would be retiring / discharging on or before **31-05-2024** may be sponsored.

2. EXPERIENCE:

Minimum 2 years of working experience on engines of Russian origin Aircraft (SU-30/MiG series) after acquiring essential qualification, as mentioned above.

3. AGE LIMIT / RELAXATION / CONCESSION:

Age limit as on 01-05-2024 is 28 years. However Ex-Servicemen who has put in not less than six months of continuous service in the Armed Forces of the Union, shall be allowed to deduct the period of such service from his actual age and if the resultant age does not exceed the maximum age limit prescribed for the post or service by more than 3 years, he is deemed to satisfy the condition regarding the age limit.

Upper age limit is relaxable by 5 years in respect of SC/ST candidates and 3 years in respect of OBC-Non Creamy Layer candidates.

Candidates belong to OBC Category are required to produce recently obtained community certificate in proof of their community at the time of document verification (not older than 06 months as on 01-05-2024) in the format prescribed by the Govt. of India, stating that they do not come under the creamy layer from the competent authority and candidates belongs to the SC/ST/PwBD Category are also required to produce their community / Disability Certificate in proof of their community / disability in the prescribed format.

In respect of Persons with benchmark Disability (PwBD) for the posts identified suitable, upper age limit is relaxable by 10 years which will be over and above the relaxation admissible for candidates belonging to SC/ST/OBC mentioned above.

For candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period 01/01/1980 to 31/12/1989, upper age limit is relaxable by 5 years.

Upper age limit with all relaxations shall not exceed 55 years. Reservation of the posts will be as per the rules.

4. TENURE OF ENGAGEMENT

The selected candidates will be engaged on tenure basis for a maximum period of Four Years from the date of engagement. The engagement is not against permanent vacancy and will not entitle any candidate to claim for regular / permanent employment in future. The tenure will come to an end automatically on completion of four years period from the date of joining, without any further notice. However, extension of tenure for a further maximum period of 04 years may be considered on case-to-case basis in cases where workload and requirement exist. The employment can be terminated, at any time, during the period of tenure engagement, by giving one month's notice by either party or payment of Basic Pay + DA components in the Consolidated Remuneration in lieu of the Notice. The Tenure Based Engagement will not confer any right on the Personnel to claim the status of a regular employee of the Company.

5. REMUNERATION

The Personnel engaged on tenure basis, against posts mentioned above, would be paid **Consolidated Remuneration** every month. The consolidated remuneration would comprise the following: -

The approximate Consolidated Remuneration for Scale – D6 (Ex-Servicemen Technician) would be Rs. 44,000/- per month at minimum level of induction and may vary depending on the number of years of experience in respect of Ex-Serviceman Technician.

6. SELECTION PROCEDURE

Candidates who are sponsored by the Sainik Boards / concerned agencies, will be called for Written Test, subject to their meeting notified criteria. Instructions regarding Written Test will be intimated to the short-listed candidates individually. Candidates qualifying in the Written Test will be called for Document Verification in the order of Merit. Candidates called for document verification will be paid IIInd Class Train fare / Actual Bus fare by shortest route on production of proof of journey.

Candidates qualifying in the Document Verification Stage will be issued the Provisional Offer of Engagement and they are required to undergo Pre-employment Medical Examination.
