

#### A GLIMPSE OF ECHS EVENTS

Tele Consultation Services through E-SeHAT. With an aim to provide online video consultation platform to ECHS beneficiaries, a project to link ECHS to the SeHAT OPD platform has been formulated. A pilot project to validate the software was conducted at all ECHS Polyclinics in Delhi and measures are being taken to resolve identified issues in the software and gradually spread the project to other polyclinics.

## OROP: Key points of Hon'ble Supreme Court judgment

The Supreme Court of India, in a judgment dated March 16, 2022, delivered by a bench comprising Justices D.Y. Chandrachud and Surya Kant, addressed the "One Rank One Pension" (OROP) policy. Here's a breakdown of the key aspects of that judgment:

#### **OROP Definition:**

- \* OROP aims to provide uniform pensions to armed forces personnel retiring at the same rank with the same length of service, regardless of their retirement date.
- \* Court's Stance:
- \* The Supreme Court upheld the Union Government's OROP policy.
- \* The court determined that the policy was not arbitrary or discriminatory.
- \* The court addressed concerns about the 2015 OROP policy and whether it deviated from the government's original policy decision.

#### **Key Points:**

- \* The court clarified that the same OROP definition applies to all pensioners, irrespective of their retirement date.
- \* All pensioners are subject to the same periodic review process.
- \*The court also addressed the way that the pension amounts were calculated, and found that the method used was a policy decision. In essence, the Supreme Court's judgment provided clarity and affirmed the validity of the government's OROP policy.

## OROP: Key points of Hon'ble Supreme Court judgment

SPARSH System for Pension Administration (RAKSHA) is a transparent pension online sanction and disbursement system. It helps Veterans brothers and their families to check their pension eligibility and details in real-time on the portal, which was not possible for pensioners in the old manual system.

Now, when they can check their data entered in the old system in SPARSH, they come to know about discrepancies in their data, so they apply for data correction through grievance. This has increased the number of grievances. But its positive aspect is that it gives them an opportunity to correct their data, which was not possible earlier. These grievances come online to our pension department, which are resolved quickly. The pension department is also updating the data at its level. This automatically corrects the pension rates etc. of the pensioners, so that their grievances can be resolved quickly and their pension or family pension continues to run smoothly.

199 SPARSH Seva Kendras are being run by our pension department in the country. Such services are provided through branches of a total of 14 banks like State Bank of India, PNB, HDFC. Apart from this, this service is also available at Common Service Centre and India Post Payments Bank (IPPB) outlets. The pension department has signed MoU with these institutions. In these centers, pensioners can get all the information related to their pension and can also get work done for the correction of their pension data.

Apart from registering complaints through SPARSH portal, pensioners can also send their pension related grievances through CPENGRAMS portal or email. These complaints are regularly monitored. The Ministry's Department of Ex-Servicemen Welfare New Delhi and Pension Office Prayagraj have a dedicated Pension Grievance Cell where pensioners can get their pension related problems resolved.

Pensioners can also call on toll free number 1800-1805-325 to get help in resolving their issues. Apart from these, SPARSH OUTREACH programmes, RAKSHA PENSION SAMADHAN AAYOJAN (RPSA), ESM Rally are regularly organized at various places where work is done on their SPARSH and pension related issues.

#### Enhancing Grievance Redressal for Ex-Servicemen

The Department of Ex-Servicemen Welfare (DESW), under the Ministry of Defence, has a primary mission: to address the welfare concerns of retired armed forces personnel and their families. One of the most vital aspects of this responsibility is ensuring that grievances, particularly pension-related issues, are resolved promptly and efficiently. Every year, approximately 50,000 grievances are registered through the CPGRAMS portal, with nearly 81% of these pertaining to pensions.



# Penury Grant by KSB

Aging comes with many challenges. The loss of independence is one potential part of the process, as are diminished physical ability and age discrimination. Because the elderly typically no longer hold jobs, finances can be a challenge. These financial challenges are more for those ex- servicemen who are non-pensioners, have no source of income and are above 65 years of age. To ameliorate their suffering in a small way, in 1981, financial assistance of Rs 100/- per month for a period of two years was introduced for non-pensioner ESM/their widows on attaining the age of 65 years. This amount was subsequently revised in 2007 by the Management Committee of AFFD Fund to Rs 500/- pm for two years with an additional one-time grant of Rs 30,000/- at the age of 70/75 years. The scheme was simplified and revised to a monthly grant of Rs. 1,000/- per month per beneficiary for life time in Oct 2011.

The present scheme provides financial assistance to non-pensioners Ex-Servicemen (ESM)/Widows in a state of penury at the rate of Rs.4,000/- per month per beneficiary for life timewith effect from April, 2017. The penury grant is provided to Ex-Servicemen upto the rank of Havildar and equivalent/their widows who are above 65 years of age and are not in receipt of any pension. The grant is funded out of Armed Forces Flag Day Fund under the scheme Raksha Mantri Ex-Servicemen Welfare Fund.
